General Terms and Conditions:

1. The motor vehicles and motor cycles will be sold on “as is where is” basis.
2. The bidder will be required to submit a Pay Order or Call Deposit for an amount equal to 2% of the total value of bid as earnest money in favor of OGRA, payable at Islamabad.
3. Any bid without earnest money or with any condition shall be rejected.
4. The successful bidder will be required to pay an amount equal to 20% the bid money in cash or through pay order, before the close of the working hours on the next working day. In case of failure to deposit the said amount with OGRA, earnest money will be forfeited in favor of OGRA.
5. On acceptance of the bid, the bidder will be required to pay the balance amount within seven (07) days in the form of pay order in favor of OGRA, payable at any bank in Islamabad and remove the vehicle immediately at his/her own risk & cost. In case of failure of the successful bidder in depositing the balance amount within prescribe time limit of seven days, his/her earnest money as well as 20% advance shall be forfeited in favor of OGRA.
6. The bids are required to be delivered to the office of the undersigned by 10:30 a.m on November 21, 2017. The Disposal Committee will open the bids on the same day at 11:00 a.m in the presence of the bidders, or their authorized representatives, who may like to be present.
7. Interested parties must bring their original or attested photocopy of CNIC with them.
8. The vehicles will be sold to the highest evaluated bidder.

9. The successful bidder will be required to pay existing/implemented/additional percentage (%) of Income Tax imposed by Government from time to time as per Income Tax Ordinance.
10. The 2% earnest money will be refunded to the unsuccessful bidders within five (05) working days of the bidding date.
11. The OGRA employees and their families will not be entitled to participate in the bidding process.
12. The disposal Committee of OGRA will open the Bids Form as per criteria on November 21, 2017 at 11:00 a.m in the presence of the bidders or their authorized representatives, who may like to be present. Bids, which are not complying by the documents at serial No. 2 above, shall be declared as Non-Responsive and their bids will not be accepted.
13. The successful bidder will ensure transfer of Registration of the vehicle in his name and will obtain private registration number within seven (07) working days after submitting balance amount and a copy to be submitted in OGRA by the bidder immediately.
